1. Orders

No artwork will be accepted without a signed order form and a valid B-BBEE certificate.

2. Media

Artwork may be supplied to us via email, CD/DVD or Flash Drives. Only the relevant files must be on the media. Please indicate if you require your media returned. Please do not send the only copy you have of the file.

3. Agency supplied artwork:

- a. Closed PDF (X1-a) all fonts converted to paths, all images 300dpi CMYK.
- b. CorelDraw X3 or X4, all fonts converted to curves.
- c. Illustrator CS3, flattened, all fonts converted to paths.
- d. CS3 PSD's, 300dpi flattened.
- e. DO NOT ADD BLEED TO ARTWORK!!!
- f. It is assumed that you hold the copyright on all images in artwork.
- g. No HAIRLINES or rules less than 0.5 points.
- h. All Pantone colours converted to CMYK.
- i. Artworks have been proofed for colour and typo's.
- j. The page dimensions must be correct.
- k. For quality purposes do not rasterize text but use embedded text for files created in Photoshop.

4. In house artwork:

Design work is billed @R300 per hour

We will create the artwork for you providing the following are met:

- a. Your logo in vector, psd or TIFF format.
- b. Any images you require (images must be minimum 300dpi at the required size, the images have to be copyright free or you should have the release).
- c. A rough outline of what you want the advert to look like.
- d. 2 sets of author changes are allowed, subsequent changes will be billed per hour.
- e. Proofs via email or printed where possible will be provided.
- f. Files in MS Word, Excel, Powerpoint, Publisher are not acceptable for litho printing and will have to be re-created at your expense.
